



SUBMISSION TERMS & CONDITIONS

1. HOW TO SUBMIT YOUR PHOTO: Visit www.diamondcabinets.com. Scroll down and click on "Learn More" in the "Real renovations: before and after" section. Click on the "Submit Now" button and follow the on-line instruction to attach photo(s) ("Photos") of your kitchen renovation that used Diamond® cabinetry, including Diamond Edge™ Series, Diamond Distinction™ Series or Diamond Vibe™ Series ("Photo" and "Submission"). You must be the copyright owner of the Submission. Photos should not include any identifiable people.

2. SUBMISSION GUIDELINES: By providing a Submission, you hereby warrant and represent that your Submission conforms to the Guidelines set forth herein. A maximum of ten (10) Photos may be submitted per submission, preferably both before and after images of the project. The Photo must be in a jpg format that is no larger than 400 KB. Any Submission that, in the sole opinion of Sponsor, is considered obscene, indecent, objectionable, or otherwise not suitable for publication will not be used. The Submission must feature current Diamond products and the submitter must provide a signed Permission to Use Photos form. The Submission must also meet the following guidelines:
